

Were we told the truth about September 11th, 2001? 10 points to consider ...

1. Fire is the official cause of the WTC collapses, NOT the jet impacts. No steel-framed building before or since 9/11 has ever collapsed due to fire, though there have been numerous towering infernos which burned longer and hotter than the Twin Towers did. The WTC Towers were in fact designed to withstand multiple Boeing 707s hitting them.
2. WTC Building 7, a 47-story skyscraper, was not struck by a plane but collapsed in 6.5 seconds at 5:20 pm on Sept. 11th, in the exact manner of a controlled demolition. The BBC reported that the building had collapsed 20 minutes BEFORE it came down. Several network news anchors reported that it looked like a controlled demolition. Explosions and flashes were observed by hundreds of eyewitnesses, including news reporters, fire men, and police officers. The same was also observed in the Twin Towers.
3. Jet fuel (basically kerosene) and other hydrocarbons have a maximum burning temperature of 1,500 F. WTC fires burned at relatively low temperatures, well under 1,500 F. The large plumes of black smoke indicated an oxygen starved, inefficient fire. Steel melts at 2,750 F. Thus, neither jet fuel nor the burning contents of the buildings could have caused the towers' steel structure to melt. Nonetheless, molten steel was indeed found under rubble many weeks after 9/11 and the intense heat was also observed in satellite photos. Large dust clouds behaved like pyroclastic flows of super heated materials in fine particles, moving at high speed through NYC streets. Massive steel beams were hurled hundreds of feet vertically. Both towers fell symmetrically in under 10 seconds: free fall speed. In other words there was no resistance from what should have been intact floors. All indications that high explosives were used. Most of the steel was immediately shipped overseas and recycled without forensic examination to determine the cause of its failure. Traces of thermate (used in demolitions) were later found on some WTC steel samples that were saved, and in WTC dust. WTC dust contained high levels of asbestos - a fire retardant and carcinogen. It would have cost over \$1 Billion to remove it from the buildings. The WTC was obsolete. Insurance paid the WTC owner \$7 Billion.
4. Scientific tests have shown that the alleged cell-phone calls by passengers could NOT have successfully made from the planes on 9/11, at altitudes over 6000 feet. The latest research indicates that there were no seat back 'airfones' on Flight 77! There are many reasons to doubt the authenticity of the reported calls which added so much personal drama to 9/11.
5. Flight 77 was known by NORAD to have been hijacked by 8:50am, yet it was a full 48 minutes until any fighters were scrambled, as two left Langley AFB just two minutes before Flight 77 hits the Pentagon at 9:40am. There are totally conflicting reports about what actually struck the Pentagon. The aircraft alleged to have been Flight 77 circled back over DC to strike the Pentagon, making a high-speed tight loop, diving at rapid rate of descent, striking an area that was being renovated and reinforced. There was NO damage to the lawn. There was only a 16 foot hole on the exterior prior to the facade collapsing, yet 3 rings of the Pentagon were penetrated. The alleged pilot, Hani Hanjour, is known to have been incompetent to fly a Cessna. No wreckage has ever been released proving that it was Flight 77. No definitive videos of the event have ever been released. Some witnesses say they smelled Cordite in the explosion - a highly explosive substance which can be used as a solid rocket fuel or in aircraft gun ammunition. The Pentagon had drilled for this exact scenario, a year prior to 9/11.
6. On September 11th, 2001 the FAA and NORAD did not scramble any jet fighters that day in a timely manner - a normal procedure occurring dozens of times per year. The standard, long standing protocols for interception were changed prior to 9/11 to require permission from the Secretary of Defence Rumsfeld, then changed back to the original protocols after September 11th, 2001. Numerous aerial war games were taking place simultaneous to the hijackings on 9/11. Many fighters had been diverted to northern Canada and Alaska. Other games involved the insertion of numerous fake planes onto radar screens, which confused ground controllers and slowed their response. Two Canadians were in charge of North American air defences that day. They have never been publicly questioned or held to account for their actions or lack thereof.
7. There was no visible airplane debris where Flight 93 allegedly crashed in Pennsylvania - only a smoking hole in the ground, much like a bomb crater with no body parts, luggage, etc. Large sections were found miles away, indicating it was actually shot down and NOT flown into the ground by heroic passengers who had stormed the cockpit, as the official story states.
8. 'Put options' were placed on both United and American Airlines in record numbers before 9/11 and large profits were made by insiders on plummeting stock prices of the two airlines involved in 9/11. Federal law protects their identities. Who else benefited from 9/11?
9. 9/11 was immediately declared an "act of war" by President Bush and Article 5 of the NATO Charter was invoked, of which Canada is a member. Canada under PM Chretien then joined the War on Terror and the invasion of Afghanistan, but was NOT obliged to send troops. Not every NATO nation sent troops and some questioned the invocation of Article 5. This invocation was the first in NATO history. There was NO Canadian investigation into the deaths of 25 of our citizens.
10. Osama bin Laden was treated for kidney disease at the American Hospital in Dubai, UAE July 4th-14th 2001. He was met by CIA station Chief Larry Mitchell. He gave Mitchell precise information regarding 'an imminent attack' on the US. Bush and members of his cabinet lied when they said they received no warnings. In fact, many documented advance warnings existed. On Sept. 10th, 2001 Osama underwent kidney dialysis at a Pakistani military hospital. Pakistan's ISI works closely with the CIA who helped to train and fund al Qaeda. Numerous news reports exist that bin Laden died in 2001. His family members in the US were flown out shortly after Sept. 11th while other planes were grounded. The Bush and bin Laden families are business partners. Bin Laden is NOT wanted by the FBI for 9/11.
